

Annotation

Upon the adoption of the 2030 Agenda for Sustainable Development in September 2015, there were several global initiatives launched, or in the process of being developed, for supporting Member States to achieve the Sustainable Development Goals. As part of those initiatives, a Technology Facilitation Mechanism is currently being established to facilitate multistakeholder collaboration and partnerships through the sharing of information, experiences, best practices and policy advice among various stakeholders. It is envisaged that the Technology Facilitation Mechanism will be a unique global gateway of information on various tools, platforms, field projects and mechanisms available for supporting countries to achieve the Sustainable Development Goals.

Panellists and delegates will deliberate on international best practices and lessons learned in the adoption, adaptation and development of green technologies. Such technologies will foster economic development while ensuring sustainable management of natural resources and balancing the three pillars of development (the social, economic and environmental dimensions). A blueprint for establishing a regional green technology database for the Asia-Pacific region, under the broader framework of the Technology Facilitation Mechanism, will also be discussed and support will be sought from member States in operationalizing this database.
